Rights of refugees and asylum-seekers. International refugee law or international human rights treaties neither articulate an explicit entitlement to asylum for the individuals concerned, nor impose an obligation on states to grant asylum. Individuals have a right to seek asylum, not to be granted asylum, and the states have the right to grant asylum, but no obligation. The Geneva Convention
